I understand that there are inherent risks of injury, including death, when participating in Rodeo type activities, which risks include but are not limited to the propensity of an animal to behave in ways that my result in injury or death to persons on or around them, the unpredictability of an animals reaction to such things as sounds, sudden movements, and unfamiliar objects, persons, or other animals or objects, hazards such as surface and subsurface conditions, collisions with other animals or objects, and the potential negligence of another participant, such as failing to maintain control over the animal or not acting within the participant's ability. Knowing and understanding the risks of participation in a Rodeo activity, including injury and death to my person and damage to my personal property, I expressly choose to assume these risks.

I hereby relinquish all claims, demands, and causes of action against Lazy L Ranch., Kualoa Ranch, Levi & Kathy Rita (Heirs& Successors) their officers, principals, representatives, employees and agents, for any damage, injury, or injury resulting in death to any of the undersigned's equipment, or personal property.
